GETTING STARTED

The first step is to speak with your tax advisor or attorney to determine the best way to make your contribution. They can guide you through the process and prepare any necessary paperwork. The library is happy to provide any information or documentation you may need.

TRACKING YOUR GIFT

The library carefully tracks all donations and works with your attorney or family designee when your contribution is received. Your wishes are recorded, and funds are allocated to the accounts you specify. Staff responsible for purchases works closely with the Library Director to ensure your donation is used as intended and provides the greatest benefit.

RECOGNITION

Donations may be acknowledged through press releases, the library website, or on the digital Donor Wall, permanently displayed inside the library. If you prefer to remain anonymous, we will respect your wishes.

TAX BENEFITS

Planned gifts can be made through the library or the HAPL Friends Foundation, a 501(c)(3) organization. The Friends work with the Library Director to manage these funds. Please consult your tax advisor or attorney to maximize any potential tax benefits.
